Preferential Policies

Through reasonable classification and preferential policies, we aim to encourage domestic enterprises to actively participate in international exhibitions, promote technological exchanges and cooperation between China and foreign countries; at the same time, attract international enterprises that have important influence and contributions to the Chinese market, drive technological innovation and industrial development in the field of circuits and systems, and support China's digital modernization drive.

Details of Preferential Policies

- i) **Registration quotas:** Beyond the registration quotas included in the basic benefits of each package, domestic exhibitors and high-influence international exhibitors are entitled to 2 additional free full registration quotas. As an alternative of 3 free full registration quotas, domestic exhibitors and high-influence international exhibitors are entitled to 25 free student tutorial quotas or 10 free IEEE member tutorial quotas.
- ii) **Promotion resources:** Domestic exhibitors are entitled to subsidies for the production of Chinese promotional materials and exclusive interview channels with domestic media and online platforms.
- iii) **Booth selection:** High-quality domestic enterprises or high-tech enterprises can give priority to selecting booths in the core area; international enterprises that have made contributions to the Chinese market are entitled to booth arrangements adjacent to leading enterprises in China's industrial chain.

Application and Review Process

- i) **Application materials:** Exhibitors shall fill in the Exhibition Application Form. Domestic exhibitors shall provide business licenses or other registration certificates; domestic high-tech enterprises shall additionally submit corresponding certificates; international contributing enterprises shall provide materials such as lists of cooperative projects, proof of R&D investment, and technical application cases.
- ii) **Submission method:** Send the application materials and relevant supporting documents to the designated conference email address.
- iii) **Review process:** After receiving the application, the organizing committee will complete the preliminary review within 10 working days. For international contributing enterprises, the organizing committee will collaborate with relevant institutions to complete the evaluation of technical contribution within 20 working days.
- iv) **Result notification:** The review results will be notified to the applying enterprises via email. After confirmation by the enterprises, the fee shall be paid at the preferential price.

Terms and Conditions

By submitting an application for ISCAS 2026 exhibit space or sponsorship, you agree to the following terms and conditions:

Admission

- I. Exhibits are open free of charge to: 1 designated representative per booth (exhibitors) and fully registered conference attendees.
- II. Additional booth staff or individuals attending only the exhibit area: \$50 per person per day (includes access to exhibits, coffee breaks, and lunch).
- III. ISCAS 2026 Exhibit Management reserves the right to refuse admission to any person (including children of exhibitors/visitors) for safety or welfare reasons.

Advertising Matter

- I. Exhibitors may distribute handbills or printed materials from their booth. Any complaints arising from such distribution will be referred to Exhibit Management for resolution.

Booth Allocation

- I. Exhibit space is assigned based on: (1) the date the application is received, and (2) the exhibitor's preferred choices (if available).
- II. If your preferred space is unavailable, Exhibit Management will assign alternative space. You may accept or refuse the alternative in writing within 5 business days.
- III. You may request that your booth not be adjacent to specific competitors; Exhibit Management will honor such requests where reasonable.

Cancellations

- I. If you cancel your sponsorship/exhibit space, Exhibit Management retains the right to keep all payments made up to the cancellation date (per the "Billing and Schedule of Payments" section of the application form).
- II. For shell scheme or rental display cancellations: A full refund is provided only if cancellation is submitted to Exhibit Management at least 10 business days before the first day of the symposium.

Electrical & Decoration Services

- I. Electrical wiring, power, and decorator services must be arranged through the Official Electrician and Official Decorator designated by Exhibit Management. Detailed information will be provided in the Exhibitor Kit.
- II. Exhibitors may provide their own electrical fittings, but installation must be done by Official Contractors (fees apply; estimates will be provided in advance).

- III. 5.6 Electrical Safety
- IV. All display wiring must comply with local governmental standards and fire inspection ordinances, and must bear the seal of official approving agencies (as required by the venue).

Prohibited Activities

- I. Exhibits or activities focused on employee recruitment (e.g., soliciting prospective employees) are strictly prohibited.
- II. Sub-leasing all or part of your booth to another manufacturer/entity is not allowed without written permission from Exhibit Management.
- III. Exhibitors may not display products not listed on the application form.

Insurance & Liability

- I. Exhibitors must maintain insurance covering: extraterritorial risks, theft, public liability, and property damage.
- II. ISCAS 2026 Exhibit Management, the venue, and their affiliates are not responsible for: injury to exhibitors/employees, loss or damage to exhibits/property (from fire, theft, accident, etc.), or lost/missing shipments.
- III. Exhibitors are liable for any damage to the venue or its equipment caused by their staff or agents.

Booth Personnel & Attire

- I. Exhibit Management reserves the right to assess whether booth personnel's attire and conduct align with the symposium's professional standards.
- II. Exhibitors and their staff may not host private events in the official venue during conference/exhibition business hours.

Photography Rights

- I. Exhibit Management retains exclusive photographic rights for the exhibition.
- II. Exhibitors may arrange private photography of their booth via the Official Photographer (fees apply) or by obtaining written permission from Exhibit Management.

Safety & Fire Laws

- I. Exhibitors must comply with all venue fire and safety regulations, including:
 - 1. Using only flameproof cloth decorations;
 - 2. Prohibiting smoking in exhibit areas;
 - 3. Ensuring exhibits do not block aisles or fire exits;
 - 4. Avoiding prohibited decorations (e.g., paper, pine boughs, non-flameproof drapes like acetate/rayon);
 - 5. No storage is permitted behind exhibits.

Termination by Exhibit Management

- II. Exhibit Management may terminate the application or cancel the symposium if:
 - 1. The venue becomes unfit for occupancy;
 - 2. The symposium is disrupted by events beyond reasonable control (e.g., fire, flood, epidemic, strike, government orders, Act of God).

- III. In such cases, Exhibitors will receive a prorated refund of their package fee (based on the number of exhibit days remaining). Exhibit Management is not liable for delays, increased costs, or losses arising from such events

Responsibility Clause

- I. Exhibitors agree to indemnify and defend the venue, ISCAS 2026 organizers, and their employees/agents against any claims or expenses arising from the use of exhibition premises.
